## BARTON VILLAGE, INC. MEETING OF THE TRUSTEES MINUTES DECEMBER 27, 2016 6 PM

PRESENT: Nate Sicard, Cathy Swain, Tin (Justin) Barton-Caplin, Kate Kran, Evan Riordan, Bernard White, Ed Barber (Newport Daily)

- A. Call to Order: NS called meeting to order at 6:02 p.m.
- B. Changes to Agenda / Additions or Deletions
  - a. JBC motioned to add Keys to Memorial Hall & Bernard White & Water Bill Error, CS seconded. Unanimous approval.
- C. Meeting Minutes November 28, 2016 & December 12, 2016
  - a. JBC motioned to approve the December 12, 2016 minutes, CS seconded. Unanimous approval.
  - b. November 28, 2016 Minutes were not included in the meeting packet
- D. Privilege of the Floor
  - a. Ed Barber asked if Trustees must be village residents.
    - Discussion included that several of the elected positions (including the Village Moderator, Village Clerk/Treasurer, Fire Chief, etc) are not required to be Village residents, but must be town residents.
    - ii. JBC stated that he believed that Trustees do need to be Village residents though the Barton Village Charter is silent on the matter other state statute governing incorporated villages.
  - b. Bernard White spoke to Trustees in regards to the billing error that the Village is now asking for the correct amount due. He stated that the requested amount of \$486 would be a hardship for his apartment residents.
    - The Trustees indicated that the situation was definitely not ideal and apologized for the inconvenience the billing error has caused; however, no adjustments or abatements would be provided.

  - JBC motion to approve Village, Water, and Waste Water budgets with a \$500 adjustment to unemployment line item and separation of Glover Rents from Waste Water revenues, CS seconded. Unanimous approval.
  - ii. Electric Budget will be approved at a future meeting
- c. Electric Lien 2613 Dane Hill Road
  - i. JBC motioned to issue the electric lien for 2613 Dane Hill Road in Charleston VT for \$260.85, CS seconded. Unanimous approval.

- e. Personnel Policy
  - i. Trustees executed the approved personnel policy
