Retail Rate Tariffs**

Standard Residential Service

AVAILABILITY:

This rate is available for single-phase electric service at secondary voltage in single family dwellings and apartments and for agricultural use within the service territory of Barton Village Electric Department where usage does not exceed 2000 kWh per month for at least two consecutive months in the past 12 month period.

MONTHLY CHARGES:

Customer Charge	\$11.46
First 100 kWh, per kWh	\$0.10213
All other energy, per kWh:	\$0.21492

MINIMUM CHARGE:

The minimum charge is the customer charge.

DURATION OF CONTRACT:

Subject to termination upon notice unless another term is applicable under the Electric Department's terms and conditions.

TERMS AND CONDITIONS:

The above rates are net, billed monthly or bi-monthly at the option of the Electric Department, except that seasonal accounts may be billed semi-annually. Such other terms and conditions of the Electric Department in effect from time to time are a part of this rate.

LATE PAYMENT PENALTY:

Bills are due and payable upon presentation. Amounts unpaid after the due date printed on the bill shall be considered in arrears and subject to a late payment penalty charge as specified in the Electric Department's rules and regulations.

TEMPORARY CHARGES:

None.

Effective on service rendered on or after April 1, 2023.

Residential Demand Service

AVAILABILITY:

This rate is available for single-phase electric service at secondary voltage in single family dwellings and apartments and for agricultural use within the service territory of Barton Village Electric Department.

APPLICABILITY:

This rate is mandatory for all residential or agricultural customers whose consumption is at least 2000 kWh per month for at least two consecutive months within the past 12 months. This rate shall remain in effect for 12 months following the determination of applicability and for such subsequent period as warranted by tariff terms.

MONTHLY CHARGES:

Customer Charge	\$36.15
First 100 kWh, per kWh	\$0.10213
All other energy, per kWh:	\$0.16705
Demand Charge, per kW:	\$8.77

BILLING DEMAND:

The billing demand shall be the higher of current metered demand or 85% of the highest metered demand occurring during the previous eleven month period.

MINIMUM CHARGE:

The minimum charge is the customer charge plus the demand charge.

DURATION OF CONTRACT:

Minimum duration is one year, subject to termination upon notice unless another term is applicable. Customers receiving service under this rate may qualify for immediate termination of service and charges under this rate and transfer of service to the standard residential rate by removing installed electric space and water heating from the load served under this rate, provided that such removal is verified by the Electric Department and is likely to reduce monthly consumption to less than 2000 kWh. If the customer's consumption subsequently exceeds the 2000 kWh limit established by this tariff, this rate will be reapplied for a minimum of one year.

TERMS AND CONDITIONS:

The above rates are net, billed monthly or bi-monthly at the option of the Electric Department, except that seasonal accounts may be billed semi-annually. Such other terms and conditions of the Electric Department in effect from time to time are a part of this rate.

LATE PAYMENT PENALTY:

Bills are due and payable upon presentation. Amounts unpaid after the due date printed on the bill shall be considered in arrears and subject to a late payment penalty charge as specified in the Electric Department's rules and regulations.

Small Commercial Service

AVAILABILITY:

This rate is available for single or three-phase electric service at primary and secondary voltage for all commercial purposes within the service territory of Barton Village Electric Department where usage does not exceed 2000 kWh per month for at least two consecutive months within the past 12 months.

MONTHLY CHARGES:

Customer Charge	\$12.23
All energy, per kWh:	\$0.21370

PRIMARY DISCOUNT:

Customer metered at the primary voltage level shall receive a 2.5% discount on all energy charges.

MINIMUM CHARGE:

The minimum charge is the customer charge.

DURATION OF CONTRACT:

Subject to termination upon notice unless another term is applicable under the Electric Department's terms and conditions.

TERMS AND CONDITIONS:

The above rates are net, billed monthly or bi-monthly at the option of the Electric Department. Such other terms and conditions of the Electric Department in effect from time to time are a part of this rate.

LATE PAYMENT PENALTY:

Bills are due and payable upon presentation. Amounts unpaid after the due date printed on the bill shall be considered in arrears and subject to a late payment penalty charge as specified in the Electric Department's rules and regulations.

Large Commercial Service

AVAILABILITY:

This rate is available for electric service at primary and secondary voltage for all commercial purposes within the service territory of Barton Village Electric Department where usage exceeds 2000 kWh per month for at least two consecutive months within the past 12 months.

APPLICABILITY:

This rate is mandatory for all commercial customers whose consumption is at least 2000 kWh per month for at least two consecutive months within the past 12 months. This rate shall remain in effect for 12 months following the determination of applicability and for such subsequent period as warranted by tariff terms.

MONTHLY CHARGES:

Customer Charge	\$88.30
All energy, per kWh:	\$0.16624
Demand Charge, per kW:	\$13.61

BILLING DEMAND:

The billing demand shall be the higher of current metered demand or 70% of the highest metered demand occurring during the previous eleven month period.

PRIMARY DISCOUNT:

Customer metered at the primary voltage level shall receive a 2.5% discount on all energy and demand charges.

MINIMUM CHARGE:

The minimum is the customer charge plus the demand charge.

THREE-PHASE POWER:

Service under this rate using three phase power shall only be available where system limitations permit.

DURATION OF CONTRACT:

Subject to termination upon notice unless another term is applicable under the Electric Department's terms and conditions.

TERMS AND CONDITIONS:

The above rates are net, billed monthly or bi-monthly at the option of the Electric Department. Such other terms and conditions of the Electric Department in effect from time to time are a part of this rate.

LATE PAYMENT PENALTY:

Bills are due and payable upon presentation. Amounts unpaid after the due date printed on the bill shall be considered in arrears and subject to a late payment penalty charge as specified in the Electric Department's rules and regulations.

DURATION:

Subject to termination upon notice unless another term is applicable under the Electric Department's terms and conditions..

HOURS OF OPERATION:

Street lights which are photo-cell controlled shall be operated from one-half hour after sunset until one-half-hour before sunrise, a total of approximately 4,294 hours each year.

CUSTOMER-OWNED STREET LIGHT EQUIPMENT ON CUSTOMER-OWNED POLES

On Customer owned poles, 1) the Customer will furnish and install all poles and

associated equipment either overhead or underground with specifications subject to Barton's prior approval or 2) the Customer may request Barton to install, in compliance with Barton standards, all poles and associated equipment based on a time and material bid price. To be eligible for this rate all equipment must be photo-cell controlled. The Customer shall be responsible for maintaining the Customer-owned portion of the streetlight system.

Barton will supply unmetered electric energy for Customer-owned outdoor photo cell controlled street lighting equipment (based on 4,294 hours of operation per year) at the rates set forth below. The monthly kWh for photo-cell controlled lighting equipment is based on the total nominal wattage of the equipment, multiplied by the annual estimated hours of operation, divided by 12 months to determine an average monthly kWh use. A customer must complete an application providing the type of light(s), total wattage of each type of light, number of each type of light being installed and general specifications, instructions, dimensions, etc. that apply to the equipment. No billing adjustments will be made for individual service outages. The Customer is responsible to provide proper and timely maintenance to ensure that photovoltaic cell controls operate properly and equipment is maintained to minimize outage time. Barton reserves the right to discontinue service upon notice under this rate if the system is not properly maintained.

CUSTOMER-OWNED STREET LIGHT EQUIPMENT ON BARTON-OWNED POLES

A customer requesting installation of customer-owned lighting on Barton-owned poles shall supply all equipment specifications for Barton approval prior to purchase and installation. Barton, or Barton designated contractor, shall install customer owned lighting systems on Barton poles at the customer's expense. Installation charges shall be on an actual time and materials basis during normal business hours. The customer is responsible for providing all of the lighting equipment and appurtenances required to install the fixtures on the poles. Barton

will maintain customer owned lighting systems on Barton poles on an actual time and materials basis. The customer is responsible for supplying all necessary materials, including any required inventory, as Barton does not stock material for customer owned systems. Barton shall own and maintain all poles, wires, and other equipment and apparatus necessary for supplying voltage to customer owned lighting systems on Utility poles.

Barton will supply unmetered electric energy for Customer-owned outdoor photo cell controlled street lighting equipment (based on 4,294 hours of operation per year) at the rates set forth below. The monthly kWh for photo-cell controlled lighting equipment is based on the total nominal wattage of the equipment, multiplied by the annual estimated hours of operation, divided by 12 months to determine an average monthly kWh use. A customer must complete an application providing the type of light(s), total wattage of each type of light, number of each type of light being installed and general specifications, instructions, dimensions, etc. that apply to the equipment. No billing adjustments will be made for individual service outages. Barton will provide proper and timely maintenance to ensure that photovoltaic cell controls operate properly and equipment is maintained to minimize outage time at the Customer's cost..

If lighting equipment owned by the customer must be replaced as a result of vandalism, accident or any other cause, the customer shall pay to Barton the cost of removal of the existing equipment and the cost of replacement equipment including installation costs. The customer shall provide necessary materials and pay for labor and other costs necessary for maintenance and repairs above and beyond lamp and photo cell maintenance, including repairs and/or the replacement of damaged lighting equipment, regardless of the cause, nature or extent of physical damage. The customer agrees to hold Barton harmless from any damage or injury relating to the customer owned equipment.

CUSTOMER REQUESTED CONVERSION OF EXISTING STREET LIGHTING EQUIPMENT OR SERVICE.

Barton shall have the right to require those Customers requesting modification or replacement of existing Street Lighting Equipment with alternative equipment or services to reimburse Barton for the un-depreciated cost of the equipment being converted or replaced, plus all costs, including make-ready costs, not recovered in the monthly charge for the alternative lighting or service. Reimbursement shall take place prior to conversion or removal of existing equipment. For purposes of this rate, LED street lighting and replacement of Barton-owned lighting with customer-owned lighting on Barton poles shall be considered to be alternative lighting equipment.

MINIMUM CHARGE:

None.

TERMS AND CONDITIONS:

The above rates are net, billed monthly or bi-monthly at the option of the Electric Department. Such other terms and conditions of the Electric Department in effect from time to time are a part of this rate.

LATE PAYMENT PENALTY:

Bills are due and payable upon presentation. Amounts unpaid after the due date printed on the bill shall be considered in arrears and subject to a late payment penalty charge as specified in the Electric Department's rules and regulations.

HOURS OF OPERATION:

Yard and Area lights which are photo-cell controlled shall be operated from one-half hour after sunset until one-half-hour before sunrise, a total of approximately 4,294 hours each year.

On Customer owned poles, 1) the Customer will furnish and install all poles and associated equipment either overhead or underground with specifications subject to Barton's prior approval or 2) the Customer may request Barton to install, in compliance with Barton standards, all poles and associated equipment based on a time and material bid price. To be eligible for this rate all equipment must be photo-cell controlled. The Customer shall be responsible for maintaining the Customer-owned portion of the lighting system.

Barton will supply unmetered electric energy for Customer-owned outdoor photo cell controlled yard and area lighting equipment (based on 4,294 hours of operation per year) at the rates set forth below. The monthly kWh for photo-cell controlled lighting equipment is based on the total nominal wattage of the equipment, multiplied by the annual estimated hours of operation, divided by 12 months to determine an average monthly kWh use. A customer must complete an application providing the type of light(s), total wattage of each type of light, number of each type of light being installed and general specifications, instructions, dimensions, etc. that apply to the equipment. No billing adjustments will be made for individual service outages. The Customer is responsible to provide proper and timely maintenance to ensure that photovoltaic cell controls operate properly and equipment is maintained to minimize outage time.
