- A. **Call to Order** Gina Lyon called the meeting to order at 6:00pm.
- B. Changes to the Agenda/Additions or Deletions None.
- C. **Privilege of the Floor** None.

ACTION ITEMS:

- D. Minutes from the Special Informational Meeting September 19, 2024 After review, Gina Lyon made a motion to approve the Minutes from the Special Informational Meeting September 19, 2024 as presented. Ellis Merchant seconded. All approved and the motion carried.
- E. **Minutes from the Regular Board of Trustees Meeting September 23, 2024** After review, Gina Lyon made a motion to approve the Minutes from the Regular Board of Trustees Meeting September 23, 2024 as presented. Ellis Merchant seconded. All approved and the motion carried.
- F. **Bills and Warrants** Gina Lyon made a motion to continue reviewing the bills and warrants throughout the meeting and approve at the end. Marilyn Prue seconded. All approved and the motion carried.
- G. <u>The Memphremagog Watershed Association</u> Patrick Hurley from the Memphremagog Watershed Association (MWA) and Mark Bannon from Bannon Engineering presented to the Board of Trustees the final designs, draft operations and management plan, draft easement from

Solid Rock Assembly of God, site access agreement/license, and letter of support regarding the clean water project in Barton Village.

The plan is to tap into an existing catch basin at the corner of School Street and Church Street, install an underground hydrodynamic separating unit behind the Solid Rock Assembly of God church, and level spreader infiltration trench near the community garden to remove debris and allow for the treatment of stormwater runoff from approximately 7 acres within the Village before it reaches the Barton River and eventually Lake Memphremagog. The MWA will be responsible for all maintenance and cleaning of the project's appurtenances and paid for through grants, at no cost to the Village.

Construction for this project likely won't begin until summer of 2025.

After discussion, Gina Lyon made a motion to approve the letter of support for the MWA clean water project as presented. Ellis Merchant seconded. All approved and the motion carried.

- H. **Driveway Access Permit Application** After discussion, Marilyn Prue made a motion to approve the driveway access permit application for access to 83 Redfield Road via Eastern Avenue. Ellis Merchant seconded. All approved and the motion carried.
- I. **Financial Reports for Period Ending 09/30/2024** After review, Marilyn Prue made a motion to approve the Financial Reports for Period Ending 09/30/2024 as presented. Gina Lyon seconded. All approved and the motion carried.
- J. ATV Ordinance At the Regular Meeting on 07/08/2024 the Trustees expressed a desire to amend the Ordinance Establishing Transit Zones for All-Terrain Vehicles on Certain Village Roads to make all public highways within Barton Village available to ATV travel 365 days a year. Whether an ordinance is adopted, amended, or repealed, the same statutorily prescribed process (24 V.S.A. § 1971) must be followed. According to this process, Gina Lyon entered the amendment into the meeting minutes by reading it aloud:

Under the authority granted in 24 V.S.A. Chapter 59, 24 V.S.A. § 2291 (4), and 23 V.S.A. § 3506 and § 3510, the Trustees of Barton Village hereby amend Section IV (A) and Section IV (B) of the Ordinance Establishing Transit Zones for All-Terrain Vehicles on Certain Village Roads by striking the same in its entirety, and replacing the same with the following:

(A) All-terrain vehicles fully conforming to the requirements of 23 V.S.A. Chapter 31 may, in accordance with the provisions of 23 V.S.A. § 3506(b)(1) of the Vermont Statutes Annotated, be operated on all public highways within the Village of Barton, in accordance with the requirements of 23 V.S.A. Chapter 31 of the Vermont Statutes Annotated as well as the requirements set forth in subparagraph (c) of this Section. (B) All-terrain vehicles may operate from 7:00am to 9:00pm, 365 days a year.

In all other respects, said Ordinance is hereby ratified and confirmed.

The full text of the ordinance will be published in the Chronicle on 10/23/2024 and posted at the Barton Village Office, Post Office, Barton Public Library, C&C Supermarket, Community National Bank, and on <u>bartonvt.com</u>. Voters have 44 days to submit a petition to protest the amendment. If no petition is submitted, the amendment will take effect on 12/13/2024.

After review, Gina Lyon made a motion to approve the amendment to the Ordinance Establishing Transit Zones for All-Terrain Vehicles on Certain Village Roads as presented. Ellis Merchant seconded. All approved and the motion carried.

K. **Truck Sander Purchase** – Due to concerns about how the salt will affect the utility bed of the 2024 GMC, this item has been tabled until 10/28/2024 when DPW Foreman Andy Sicard will be available to answer questions.

DISCUSSION ITEMS:

L. **Barton Community Giving Garden** – Cindy Delano provided the Board with a brief update on the Barton Community Giving Garden's activities for 2024. Some projects have been put on hold pending the start of the MWA project. They also reported that they had several new volunteers and requested guidance on whether it would be better to pay a local teen for mowing as a contractor or as a Village employee. Business Manager Vera LaPorte or Crystal Currier will look into it.

M. Flood Update

- 09/24/2024 Received RIVER project recommendation from Stantec Engineering and NVDA. The only recommendation made was buying/elevating homes on Glover Road. FEMA is already aiding interested homeowners in this regard.
- 10/03/2024 "Kickoff" call with VEM consultant.
- 10/09/2024 Exploratory call with VEM/FEMA to go over Disaster Inventory. Recovery Scoping Meeting will be held approximately two weeks after.
- Aqueduct Initial research by VT State Rail & Aviation Bureau indicates that it is not owned by the railroad. Stantec Engineering to send information on their findings/suggestions soon.
- Ball Field More backfilling needed. Will involve the softball association about how they would like everything laid out.
- High Street Currently accepting bids on guard rail replacement. None received at the time of the meeting. Will consider jersey barriers as temporary solution.
- Pageant Park Road Currently accepting bids on culvert installation and will inform residents when work will take place.

- Electric Department
 - o After-hours on-call service will be changed to New England Call Center.
 - Tariff rider is pending review with the PUC.
 - VPPSA General Manager Ken Nolan will attend the Regular Trustees Meeting on 11/11/2024 to continue discussion on AMI.
- Wastewater Department
 - Operating well and all reporting deadlines are being met.
- Water Department
 - o Operating well and all reporting deadlines are being met.
- Highway Department
 - o Paving continues between flood recovery projects.
 - DPW Utility Worker Garrett Heath has been accepted to linemen school and will attend in May 2025.
- Village Department
 - Still shopping for school crossing signs.
 - o Working on easement and final report in the Washington Terrace matter.
 - Municipal tickets have been received from the VT Judiciary and ordinance enforcement may continue.
 - Interviews for Lead Finance/HR position have concluded, and a decision on an offer is expected to be made after discussion.

OTHER ITEMS:

O. Other Business

- Gina Lyon asked about the status of the salt/sand shed project. Vera LaPorte informed
 her that it may be time to apply for the remaining funding required and send out
 requests for proposals (RFPs). Salt and sand deliveries have already been scheduled and
 will occur more frequently than they had in the past because the Village is now
 responsible for maintaining all its roads. The temporary salt/sand shed built by the
 Highway Department will have to be removed so the new permanent structure can be
 built. This likely won't take place until 2025.
- Gina Lyon stated that the sinking culvert on Eastern Avenue is rapidly getting worse. She
 expressed concern that ditching done on private property in the area may be
 contributing to its decline. Vera LaPorte will have DPW Foreman Andy Sicard investigate
 further.
- Gina Lyon asked about the repair status of Bethany Ford's property (damage resulting from water main leak/repair on Lincoln Avenue). Andy Sicard was supposed to have already cleaned and seeded the area. Vera LaPorte will confirm with him that the work was done.
- Gina Lyon reminded the Board that Representative Katherine Sims organized a tour of Barton with various state officials for the purpose of identifying areas/projects in need of funding. The tour is scheduled to begin at 9:00am on 10/18/2024. The full agenda for the tour can be found at https://bartonvt.com/agenda-minutes/.

 Gina Lyon asked the Board to consider possible dates for a simple public celebration acknowledging the 150th anniversary of the Village's incorporation. 11/16/2024 and 11/23/2024 were suggested as possibilities.

Funds are apportioned to federal agencies, and to the 50 states and 6 territories through the U.S. Department of the Interior National Park Service (NPS). In Vermont, LWCF is administered by the Vermont Department of Forests, Parks & Recreation.

- Development of new outdoor recreation facilities
- Renovation of existing facilities for outdoor recreation







- 08/15/2024 Shortfall in FEMA Public Assistance announced and Immediate Needs Funding (INF) implemented.
- 08/20/2024 FEMA DR-4810 declared.
- 08/23/2024 Assistance applicant briefing with Vermont Emergency Management (VEM).
- 08/27/2024 NVDA and STANTEC inspection.

- 09/27/2024 Received STANTEC/NVDA RIVER project recommendation to buyout/elevate homes on Glover Road and Elm Street. "Due to the steep topography, and the use restrictions on the only open parcel where flood

storage could occur, the best solution to mitigate flooding here is to buyout the parcels/homes that are experiencing flooding. Recommend structure elevation or mitigation reconstruction as an alternative." Subsequent meetings have determined that no projects in Barton Village will be recommended at this time.

- 10/03/2024 "Kickoff" call with VEM consultant.
- 10/09/2024 Exploratory call with VEM/FEMA PDMG to go over Disaster Inventory. Recovery Scoping Meeting will be held in approximately 2 weeks.
- 10/25/2024 Disaster Inventory submitted.

Buyouts

- Grant awards for DR-4720 buyouts cannot be made until after FEMA's INF is lifted.
- Two property owners have completed the buyout paperwork.
- One property owner interested in the elevation program has since withdrawn interest.
- The deadline for submitting buyouts/elevations for DR-4720 has passed. Anyone interested in a buyout/elevation will need to apply under DR-4810.
- Email from VEM on 09/19/2024 requested that municipalities update the property owners on FEMA's funding issues. Both property owners updated on 09/19/2024.

DPW

- Lincoln Avenue
 - Initial research by VT State Rail and Aviation Bureau indicates the aqueduct is not owned by the railroad. STANTEC has no information to provide at this time, however David Snedeker with NVDA has offered to assist with applying for grant funding for legal/surveying fees if the Village wishes to take ownership.
- Ball Field
 - The softball association has moved to Glover and will not be able to assist with cleanup and guidance. DPW Foreman Andy Sicard will be in touch with someone in the area from the minor league who can possibly help.
- High Street/St. Paul's Cemetery Access Road
 - Culvert/road is currently stable and will be addressed with FEMA Hazard Mitigation.
 - Guard rail will be installed the week of 11/11/2024.
- Pageant Park Road Culvert
 - Replacement culvert is ordered and should arrive the week of 10/28/2024. Currently working with contractor to determine the best method of installation and scheduling.

No other updates at this time.

Electric Department

- After-hours on-call answering service will be changed to New England Call Center ASAP.
- Tariff rider has been submitted to the PUC and is pending review.
- Electric sales to Pageant Park's seasonal campers totaled \$3,538.31.
- Vera LaPorte attended a meeting with Steve Farman (VPPSA), Scott Johnstone (Morrisville Water & Light) and a State contractor regarding the electrification of the RCT fleet and possible locations for storage and EV charging stations. The charging stations would require three-phase service and several locations throughout the Village were identified as possibilities. This project is currently in the study phase.
- Ken Nolan (VPPSA) will be attending the Regular BOT Meeting on 11/11/2024 to continue discussions about Advanced Metering Infrastructure (AMI).

Wastewater Department

- Glover agreement Since the Glover agreement is based mainly on flow and BOD/TSS, Mike Mainer with Aldritch & Eliott has advised against updating it until it can be determined with 100% certainty that the high strength wastewater originates from Glover's users. He has been given some data to make the determination, but more sampling may need to be done.
- Facility upgrade Mike Mainer would like to submit the final report to the State by the end of the year. He also suggested visiting Hardwick's wastewater facility as it is very similar to the upgrade option that the Trustees are considering.
- The wastewater treatment facility continues to operate well and all reporting deadlines are being met.

Water Department

- The Vermont Bond Bank Small System Capacity and Resiliency Program (SCRP) Tier II grant applications are currently being accepted. Backup generators unfortunately do not meet the criteria but refurbishing the carbon filters may, as well as the previously purchased chlorine analyzer. Applications are due 12/02/2024.
- A recent audit of water/sewer accounts produced several meters that are underperforming or may not be reading at all. DPW Foreman Andy Sicard and DPW Utility Worker Garrett Heath are working on testing/replacing them.
- The water treatment facility continues to operate well and all reporting deadlines are being met.

Highway Department

- Paving is complete for the season. The potholes on School Street, Church Street, and Pageant Park Road have all been filled.
- The failing culvert on Eastern Avenue has apparently been a known issue since 2021. Andy Sicard and Garrett Heath have shored up the area with riprap and ditching. This project may be eligible for grant funding through the <u>2026 Vermont</u> <u>Better Roads Program</u> (20% grant match if project is \$60,000 or less). Applications are due 12/27/2024.
- Bethany Ford's property has been cleaned up and re-seeded.
- Salt/sand shed Tyler Billingsly is working on the RFP and hopes to have it in place by the end of the year and bids accepted for construction in spring of 2025.
 Community National Bank and Passumpsic Bank have both shown interest in financing the remaining amount required.
- Ditching around the Village has begun with Roaring Brook Road, Glover Road, Vigario Lane, and High Street in particular focus.
- See Flood Update for additional information.

Village Department

- School crossing signs All the prep work has been done to install the signs but they are more expensive than originally anticipated (over \$5,000). Currently getting more quotes from suppliers.
- The Village received \$20,000 of the promised \$80,000 flood recovery funds from the FY24 Budget Adjustment Act. Marilyn Prue has provided some helpful insight on the intended use of these funds.
- The BOT inspected Washington Terrace (TH422) on 08/21/2024 as part of the process of discontinuing the road. Vera LaPorte working on easement with Kevin Henry at Primmer & Piper and the final report.
- Offer of employment for the Lead Finance/HR position was extended to Amy Braun and she accepted. Her first day was 10/21/2024.
- Crystal Currier (VPPSA) has offered to stay on one day per week after retirement to wrap up some projects and continue training her replacement.

- The ATV Ordinance amendment was published in the Chronicle on 10/23/2024 and posted at the Village office, C&C Supermarket, Post Office, Community National Bank, and the Barton Public Library.
