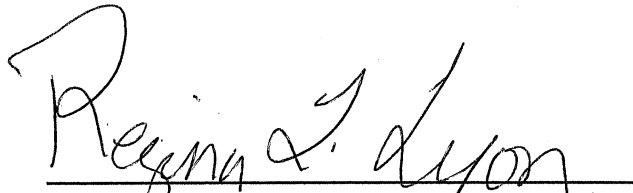
E. Other Business – None.
